1. CALL TO ORDER

Interim CAO Jennifer McAdam called the Meeting to order at 1:00 pm

2. APPROVAL OF THE AGENDA

M#13-326 Moved by Councillor Erickson to approve the Agenda with the addition to Item 8 of the Proposed Amendment to Bylaw 09-2012 - Bylaw 06-2013

3. OFFICIAL ELECTION RESULTS AND INTRODUCTION OF COUNCIL MEMBERS - Interim CAO McAdam reviewed the election results and introduced the newly elected Council Members

4. APPOINTMENT OF ELECTED OFFICIALS

The Municipal Administrator administered Official Oaths for each elected member of Council (as councillors).

5. APPOINTMENT OF MAYOR

The Administrator called for nominees for the position of Mayor.

Councillor Heimbeckner nominated Councillor Lindsay as Mayor.

CARRIED UNANIMOUSLY

Interim CAO McAdam declared Councillor Lindsay as the Mayor for the next ensuing year and administered the Official Oath for the Office of Mayor.

Interim CAO McAdam turned the Meeting over to Mayor Lindsay.

6. APPOINTMENT OF DEPUTY MAYOR

Administration explained the process for appointing the Deputy Mayor, as provided in Procedure Bylaw 09-2012.

M#13-328 Moved by Councillor Little that Councillor Art Erickson be appointed as Deputy Mayor for the ensuing six-month term, being October 28, 2013 – April 30, 2014 and further that Councillor Clark Heimbeckner be appointed as Deputy Mayor for the six-month term, being May 1, 2014 to Organizational Meeting, 2014.

CARRIED UNANIMOUSLY

Interim CAO McAdam administered the Official Oath for the Office of Deputy Mayor to Councillors Erickson and Heimbeckner.

7. APPOINTMENT OF THE MUNICIPAL ADMINISTRATOR

M#13-329 Moved by Councillor Smylie that Jennifer McAdam be appointed as interim Chief Administrative Officer (CAO) for the Village of Wabamun, effective October 23, 2013.
