

BYLAW NO. 10-2014 OF THE VILLAGE OF WABAMUN IN THE PROVINCE OF ALBERTA

THIS BEING A BYLAW OF THE VILLAGE OF WABAMUN, IN THE PROVINCE OF ALBERTA, TO AMEND THE VILLAGE OF WABAMUN LAND USE BYLAW 07-2010.

PURSUANT, To Sections 7, 692 and 606 of the Municipal

Government Act, Revised Statutes of Alberta, 2000,

Chapter M-26.

WHEREAS, The Council of the Village of Wabamun deems it necessary

to amend the Village of Wabamun Land Use Bylaw No. 07-

2010;

NOW THEREFORE, The Council of the Village of Wabamun, in the Province

of Alberta, duly assembled, enacts the following

changes:

That parcels denoted on the attached map 'Appendix A' be rezoned as follows

Plan 3682AJ Lot 3 Bk 2 from R1 Residential – Single Unit to C1 Commercial

Plan 3682AJ Lot 2 Bk 2 from R1 Residential – Single Unit to C1 Commercial

Plan 3682AJ Lot 1 Bk 2 from R1 Residential – Single Unit to C1 Commercial

Plan 5340AX Lot R Bk 2 from R1 Residential Single Unit to R3 Residential Multi Unit Plan 5340AX Lot S Bk 2 from R1 Residential Single Unit to R3 Residential Multi Unit Plan 5340AX Lot T Bk 2 from R1 Residential Single Unit to R3 Residential Multi Unit

This Bylaw comes into full force and effect upon third and final reading.
