



**BYLAW NO. 05-2013
OF THE
VILLAGE OF WABAMUN
IN THE PROVINCE OF ALBERTA**

**BEING A BYLAW OF THE VILLAGE OF WABAMUN, IN THE PROVINCE OF ALBERTA, TO
AMEND LAND USE BYLAW NO. 07-2010 OF THE VILLAGE OF WABAMUN**

WHEREAS a Council of the Municipality may, pursuant to Section 7 of the Municipal Government Act, being Chapter M-26 of the Revised Statutes of Alberta 2000, and any amendments thereto, pass bylaws amending the Land Use Bylaw

WHEREAS the Village of Wabamun wishes to provide for, define and regulate the operation of a Recycling Depot within the Municipality under the Land Use Bylaw 07-2010

WHEREAS the use of a Recycling Depot is not defined under Section 1.5 INTERPRETATIONS and is excluded from both the permitted and discretionary uses under Section 7.11 VC – Village Centre of the Village of Wabamun Land Use Bylaw 07-2010

WHEREAS it is deemed desirable to amend the Land Use Bylaw pursuant to Division 12 (Section 692) of the Municipal Government Act, RSA 2000, Chapters M-26

NOW THEREFORE, the Council of the Village of Wabamun, duly assembled, hereby enacts the following:

The Village of Wabamun Land Use Bylaw 07-2010 is hereby amended by making the following changes:

1. adding to Section 1.5 INTERPRETATION

RECYCLING shall mean “to do anything that results in providing a use for a thing that otherwise would be disposed of or dealt with as waste, including collecting, transporting, handling, sorting, storing, separating and processing the thing, but does not include the application of waste to land or the use of a thermal destruction process”

DEPOT shall mean “a place operated as a business for the collection of empty containers including but not limited to, bottles, cans, plastic cups or paperboard carton or package made of metal, plastic, paper, glass or other material, or a combination of them, that contains or has contained a beverage”

2. adding to Section 7.11.2 VC – Village Centre as a Permitted Use

RECYCLING DEPOT

AND WHEREAS this Bylaw shall come into full force and effect upon third reading.
